- All vendors will be notified of their approval via email

## **Ansonia Farmers Market Rules and Guidelines**

- Vendors at the Ansonia Farmers Market are to park only in the specified area. Each vendor will be assigned adequate spaces based on needs specified in their application and market availability.
- Producers may sell at the Ansonia Farmers Market only on the announced days of the market: **Fridays, June 11<sup>th</sup>-October 29th from 10am – 1pm**
- Market will occur Rain or Shine.
- Vendors selling prepared foods or produce must separately apply for and provide a copy of their vendor permit from the of Naugatuck Valley Health District.
- Vendors are to pay an annual fee TBD. Annual fees TBD by vendors, if necessary
- Vendors shall sell only agricultural, horticultural, or food items that they themselves have grown, produced, or processed, unless otherwise given permission by the Ansonia Farmers Market at the time application is submitted. The Ansonia Farmers Market strives to provide a market place where fresh and wholesome products are sold. The Market Manager shall have the responsibility for maintaining quality control at the Market. The vendor should be the seller of their product at the Market. (Exceptions may be discussed with the Market Manager.) All craft products must be handcrafted by applying vendor and pre-approved by the Market Manager.
- This is a WIC certified market. All produce/specialty farm vendors must be certified through the CT Dept of Agriculture. Crop and Specialty Crop Plans must be filed with the state and market master annually. All applicable vendors must abide by the regulations regarding the WIC program.
- There will be no sales of produce prior to the opening of the market.
- Sellers should have their prices displayed.
- Each producer shall display a sign which states the producer's name and address.
- Producers must remove unsold produce and clean up their stalls before leaving the market.
- **HEALTH PRACTICES:** All vendors must adhere to health and sanitation codes as outlined by the State of Connecticut and local Health Department. Any vendors found selling foodstuffs or produce, or in the Market without proper health precautions, shall be suspended from selling operations until satisfactory clearance has been obtained.
- All vendors must dress appropriately and shoes and shirts are required. NO dogs or pets are allowed in food vendor stalls.
- Seller assumes full liability for the products market or sell
- THE MARKET MANAGER RESERVES THE RIGHT TO DENY VENDOR PRIVILEGES TO ANY VENDOR THAT FAILS TO COMPLY WITH THESE VENDOR RULES OR FOR ANY VIOLATION OF CITY, STATE OR FEDERAL LAWS RELATED TO VENDOR ACTIVITIES DURING MARKET.
